British Columbia Investment Management Corporation (bcIMC)	For	This meeting replaces the special meeting in July that was cancelled because of a lack of sufficient shareholder support for a proposal by founder and CEO Michael Dell and private equity firm Silver Lake Partners to privatize the company. The price consideration of the proposed deal has been improved by approximately 1.7% to \$13.88 per share, including an additional dividend of \$0.13 per share, and represents a premium over the pre-offer share price of 27.6%. bclMC continue to support the transaction because of the price premium, the transfer of the risk of the deteriorating personal computer market to the buyers, and the certainty of value that will allow bclMC to use the capital to pursue other opportunities. Carl Icahn who opposed the deal and made his own proposal has conceded defeat. In addition to the revised terms of the deal, Dell made two changes for this meeting, changing the record date and changing the vote requirement, both of which would normally raise significant procedural and fairness concerns with shareholders. The record date change was mainly dictated by state law requirements that the meeting be held within 60 days of the pronounced record date and the period had expired. The vote standard was changed from a majority of disinterested shares outstanding to a majority of disinterested votes cast because there was a high percentage of votes not cast for the first vote. It is impossible to know the reasons why a shareholder fails to vote but having such non-votes effectively count as no votes also raises concerns of fairness. The overall requirement that a majority of uninterested shareholders approve the deal remains and bclMC favours a standard that requires an active decision by shareholders, either a vote for or a vote against.
